- · I release and hold harmless American Heritage Summer Day Camp, its officers, trustees, directors, employees, and agents from any responsibility or liability for any lost, stolen, or damaged personal property which my camper(s) brings to camp.
- If I cannot be reached, I hereby give permission for emergency medical treatment, emergency transportation, hospitalization, anesthesia, x-ray or necessary injections for my camper(s), and will be responsible for the bills of same.
